Resolution to Petition the People of the Village of Mayville and the Incorporated Village

WHEREAS, the Village of Mayville is a Michigan Municipal Corporation incorporated under Michigan Public Act 326 of 1887; and

WHEREAS, the Village Council is the governing body of the local governmental unit the Village of Mayville as established under Michigan Public Act 3 of 1895; and

WHEREAS, an authorized local government unit may establish an Industrial Development District under Michigan Public Act 198 of 1974; and

WHEREAS, the Village Council desires to file petition within the Village of Mayville to consider the establishment of a Industrial Development District;

NOW, THEREFORE, BE IT RESOLVED by the Village Council of the Village of Mayville that this notice of petition be filed with the Village Clerk and the People of the Village of Mayville, and proper public notice shall be given for the establishment of an Industrial Development District within the corporate limits of the Village of Mayville,

BE IT RESOLVED, that the Village Council petitions the People of the Village of Mayville,

BE IT RESOLVED, that the Village Council petitions the taxpayers of the Village of Mayville,

BE IT RESOLVED, that the Village Council petitions the taxing units with jurisdiction within the Village of Mayville,

BE IT RESOLVED, that the Village Council notifies the Administration of the Village of Mayville that the following parcel of land herein described, approximately 22 acres, is the area proposed for the establishment of an Industrial Development District,

BE IT RESOLVED, by the Village Council of the Village of Mayville that the following described parcel of land situated in the Village of Mayville, County of Tuscola, and State of Michigan, to wit:

A parcel of land in the West 1/2 of the Southwest 1/4 of Section 25, Town 11 North, Range 9 East, described as follows: to fix the point of beginning, commence at the West 1/4 corner of said Section 25; thence South 00 degrees 00 minutes 40 seconds West, on the West line of said Section, 159.10 feet to a point on the arc of a curve to the right having a radius of 3819.71 feet, thence Southeasterly on the arc of said curve to the right; being the centerline of Highway M-24 right of way, 427.95 feet to the point of beginning of this description, said curve being subtended by a chord bearing South 80 degrees 18 minutes 44 seconds East, and distance of 427.72 feet; thence continuing Southeasterly on the arc of said curve to the right; being the centerline of Highway M-24 right of way, 965.95 feet, to the East line of said West 1/2 of the Southwest 1/4, said curve being subtended by a chord bearing South 69 degrees 51 minutes 30 seconds East, and distance of 963.38 feet; thence South 00 degrees 02 minutes 20 seconds West, on said East line, 1013.52 feet to the Northeasterly line of the Chesapeake and Ohio Railway right of way; thence North 73 degrees 54 minutes 10 seconds West on said Northeasterly line, 516.41 feet to the point of curvature of a curve to the right, said curve having a radius of 2814.93 feet; thence Northwesterly on the arc of said curve, 435.92 feet; said curve being subtended by a chord bearing North 69 degrees 27 minutes 59 seconds West, and a distance of 435.49 feet; thence North 00 degrees 00 minutes 40 seconds West, parallel with said West Section line, 1049.31 feet to the point of beginning.
